Body Buster™ Terms and Conditions (see reverse for additional policies, terms, and conditions)

1. Body Buster, and/or any agents working on behalf of Body Buster are herein referred to as Body Buster.
2. **OPTION 1** - The Member agrees and authorizes Body Buster to charge the Member's credit card on a consecutive monthly basis starting with the date of program registration and continuing for each and every month that follows up to a total number charges to the pMember's credit card equal to the number of consecutive programs set out in the registration. (For example, if the Member signs up for 3 consecutive programs, the Member's credit card will be charged the discount price on the day of sign up and on the same day in the next two months). The Member understands that the monthly charge to her/his credit card is determined by the day of sign up and does not correspond to the actual dates the programs start. If this credit card charge is declined for any reason, the Member authorizes Body Buster to charge the Member's credit card per the Credit Card Information for the full amount for that program's payment due and for any charges incurred by Body Buster as a result of the original charge being declined.
3. **OPTION 2** - In the event of payment not received before the start of your first scheduled class, or one or more of the post dated cheques not clearing for any reason, including, but not limited to, being NSF (Not Sufficient Funds), the Member hereby authorizes Body Buster to charge the Member's credit card per the Credit Card Information for the full amount for that program's payment due and for any bank charges incurred by Body Buster as a result of a cheque being refused by the bank.
4. The Member agrees that all Body Buster orders, purchases, and/or registrations (including, but not limited to, payments, memberships, programs, classes, merchandise, equipment, clothing, and products) are non-refundable, non-transferable, and cannot be cancelled.
5. The Member agrees and authorizes Body Buster to retain this information, and charge the Member's credit card for any future payments due.

Body Buster Inc. General Policies, Terms, and Conditions

1. Body Buster, Body Buster Inc., Body Buster Bootcamp, Body Buster Boot Camp, Body Buster Fitness, Body Buster Fitness Bootcamp, Body Buster Fitness Boot Camp, Body Buster Personal Training, Body Buster Nutrition, Body Buster Nutrition and Wellness, Body Buster management, staff, associated person(s), entities, and agents working on behalf of Body Buster are herein referred to as Body Buster.
2. All Body Buster orders, purchases, and/or registrations (including, but not limited to, payments, memberships, programs, classes, merchandise, equipment, clothing, and products) are non-refundable, non-transferable, and cannot be cancelled.
3. *Schedule 1*: Members are required to provide Credit Card Information by completing Schedule 1 at the time of entering into any multiple program contract with Body Buster and authorize Body Buster to retain this information, and charge the Member's credit card for any future payments due.
4. *Cheque / Cash Payments*: In the event of payment not received before the start of your first scheduled class or if a Member's cheques does not clear for any reason, including but not limited to being NSF (Not Sufficient Funds), the Member hereby authorizes Body Buster to charge the Member's credit card per the Credit Card Information in Schedule 1 for the full amount for that program's payment due and for any additional charges incurred by Body Buster as a result of a cheque being refused by the bank.
5. *Recurring Credit Card Billing*: If the Member is on recurring credit card billing for a multiple program contract, the Member agrees and authorizes Body Buster to charge the Member's credit card on a consecutive monthly basis starting on the date registration and continuing for each and every month that follows up to a total number charges to the Member's credit card equal to the number of consecutive programs set out in the multiple program contract. For example, if the Member signs up for three (3) consecutive programs, the Member's credit card will be charged the discount price on the day of sign up and on the same day in the next two months. The monthly charge to her/his credit card is determined by the day of sign up and does not correspond to the actual dates the programs start.
6. Members shall be responsible for, and guarantee, all payments to be made to Body Buster under the policies, terms, and conditions of Body Buster, notwithstanding and regardless of the Member's attendance, willingness, or ability to participate in Body Buster activities, any extended absence, or medical condition.
7. Body Buster may cancel a member's class, program, and/or membership at any time at the discretion of Body Buster for any reason, including, but not limited to, insufficient enrollment.
8. All members have the right to a positive, safe, supportive, and non-disruptive class environment, and that any violation of law or this condition (including, but not limited to, the use of profanity and/or making disparaging remarks), at the discretion of Body Buster, may result in the Member being removed from the class and/or program without refund of any portion of his/her class/program price or charges.
9. The schedule, location, instructor, or content of fitness classes may be changed on occasion, without compensation to the Member, and may be due to circumstances beyond the control of Body Buster.
10. *Makeup Classes*: Members may request up to two (2) makeup classes per program if the Member is unable to attend a class at her/his home location. Requests for a makeup class are to be submitted through CRIS at <http://www.bodybusterfitness.com/cris> and such requests must be made 48 hours in advance of the missed class. The Member may only make up classes subject to availability and the consent of Body Buster. The makeup class must take place in the program a class is missed and cannot, and will not be carried forward to a future program.
11. *CRIS Online*: Members have free access to CRIS (Client Registration Information System) to request makeup classes. CRIS is a fully automated web-based system and is available to all paid members.
12. *Extended Absence*: Should the Member be away for an extended absence (one to four weeks), the Member must give Body Buster 30 days notice in writing stating the Member's absence and its details. Subject to permission being granted by Body Buster, the Member may make up classes missed due to an extended absence. Permission shall not be granted for more than one extended absence per multiple program contract.
13. *Illness*: If the Member is unable to participate in Body Buster classes due to medical illness or injury, the Member may be allowed to make up missed classes in a future program, conditional on providing *immediate* notification to Body Buster documentation from a physician* stating that the Member is/was not capable of attending class due to medical illness or injury, and that only those classes missed where notification was provided in a timely manner may qualify for makeup.
14. *Deferral due to illness*: If the Member defers any classes due to medical illness or injury, the Member cannot return to class until the Member provides documentation from a physician* stating that the Member is fit to do so.
15. There are risks associated with any and all Body Buster activities, and that such activities may be an extreme challenge to the Member's physical and mental abilities. Members should have a regular medical examination prior to participating in any Body Buster activity.
16. *Physician*: The term *physician* refers to any medical doctor or specialist licensed to practice medicine in Ontario, and who is certified and registered in good standing with The College of Physicians and Surgeons of Ontario.
17. *Service Charges*: All class scheduling requests are handled online, and subject to the policies, terms, and conditions above. Any requests for exemptions from these policies, including, but not limited to, makeup class request without 48 hours prior notice of missed class, may be subject to a service charge. Any requests made outside CRIS, including, but not limited to, email and telephone requests for classes changes may be subject to a service charge.
18. All Body Buster activities carry with them the potential of harm to the Member's self, the Member's property, loss or damage to the Member's possessions, bodily injury and death. Members understand and accept all risks associated with the Member's participation in the Body Buster program and agree to hold harmless Body Buster's management, staff, associated person(s), and/or entities from and against any and all liability for any harm to the Member's self or the Member's property that may arise from the Member's participation in any Body Buster activity.
19. While participating in any Body Buster activity, photos, video, and/or audio may be captured/recorded for the purpose of marketing/advertising, and Members authorize Body Buster to use any and all photos, video, and/or audio for the purposes of marketing/advertising without compensation to the Member.
